- To comply with the directives of Hon'ble Supreme Court of India requiring all employers to develop and implement a policy for prevention of sexual harassment at the workplace.
- To evolve a permanent mechanism for the prevention and redressal of sexual harassment cases and other acts of gender-based violence at the workplace.
- To follow and implement the Act enjoining all employers to constitute an "Internal Complaints Committee" and lay down guidelines for redressal of complaint related to sexual harassment of Women at the workplace.

### Preventive measures taken in campus

- CCTV installed at all common places
- Staff oriented on rules and consequences of flouting the rules
- Periodic meeting with staff on one-to-one basis by committee members to know about their welfare
